

Football Village – Privacy Policy

Here at Football Village we pay extreme attention to protecting the Privacy of our Users. This document about our Privacy policies, aims to inform them about how we protect their data, according to the existing laws. It is also very important and a mandatory requirement to access our services to read, understand and approve the following policy.

For any children under 18 of age it is required the parent's or legal guardian's permission to complete the registration and to access the service.

Once you have clicked on "Accept" during the registration process, you will give your express consent for which your personal data and information may be gathered and processed by E-Calcio S.r.l. according to this Privacy Policy.

Consent for processing personal data

Using the services of the Football Village website requires the consent to the collection and the treatment of the personal data of the User from part of E-Calcio S.r.l. like described in this document. Such data will be used confidentially and in agreement with the enforced laws in matter of privacy and treatment of the personal data. E-Calcio S.r.l. reserves the right to modify this privacy policy at any time without warning. Any modification will be notified and documented on this web page.

Personal data and information

The personal data of the Users of Football Village are collected at the moment of the registration to the website through a specific form, followed by an email confirmation to validate your registration attempt. Further information may be collected automatically every time the User will access Football Village and its services.

Purposes of collection of personal data

Personal data of the Users gathered and collected through the Football Village website, may be used for the following purposes:

- To analyse the behaviour of the Users so as to allow us to better understand their necessities and their desires, with the final goal to offer to all the best Service possible
- To send informative material regarding Football Village and its services, in order to inform the User about special offers, promotions and activities
- To allow the User to send emails or private messages to the other Users of Football Village without having them access any personal data or information of the User
- To manage the User's Account from the Football Village website and receive any important communication regarding it
- To create and to maintain a database of information for internal usage, to be used for consultations or for elaborations of statistics
- To offer communications and personalized information about Football Village, the world of soccer in a generalized manner, or about third parties that based on the data in our possession we think can be of interest for the User.

Chat System and Discussion Forum

In Football Village a Chat System and a Discussion Forum are serviced for the Users to allow them to communicate and exchange messages and opinions. Every information revealed from the User through these instruments will be published and in any case considered as public. For this reason we invite our Users to pay particular attention to the messages sent through the Chat System and the Discussion Forum of Football Village and the information that they carry, above all if these regard third persons (physical or legal). For more information please refer to the Terms and the Conditions of the Service.

Access, update, correct or delete your personal data

Every User of Football Village has the right to access their own personal data and to modify them, to cancel them or to update them at any time. Moreover it is possible to demand the cessation of the use of this personal data by sending appropriate request via email to the address privacy@footballvillage.net or through the appropriate option in the management panel of the Account.

In the registration form all the fields denoted by an asterisk ("*") are considered as mandatory; these information are considered as fundamental and necessary for accessing and using the Service. The fields not denoted by an asterisk are instead optional and can be left empty.

By accepting this privacy policy about the treatment of the personal data and by completing the registration process, the User guarantees that the personal data provided to E-Calcio S.r.l. are truthful, correct, complete and updated, and that eventual alterations will be communicated in a timely manner by the User.

Football Village may send periodic newsletters and other relevant communications about the Service, if the User does not want to receive this type of communications or communications of third parts will be sufficient to select the proper option in the registration form. It will be however always possible later on to change these choices from the panel of management of the Account of Football Village.

Personal data security

All the information provided by the Users of Football Village are encrypted and codified automatically from your Internet browser (in case your browser should not support this functionality, the transmission will not be carried out). The information sent off from your browser towards the Football Village website can be decoded and interpreted only by our systems and by the authorized personnel, in Agreement with the enforced Laws about the treatment of privacy and personal data.

Minor of age

Football Village is a Service directed to the utilization and to the consultation by adult persons. Any person under the age of 18 is not allowed to provide us any personal data or information or to use the tools of communication available to the Users of our Service without the express approval and consent of the parents or of a guardian.

In case a minor of age should reveal relevant personal information using one of the tools of communication of Football Village (Chat System or Forum of Discussion), this might lead to the future reception of unwanted messages not requested by the User. It is an obligation for the parents or for the legal guardian to make sure that the minor of age User respects the limits and the conditions of our Service.

E-Calcio S.r.l. advises that the connections carried out from the minor of age to the Service and the Chat System happen always in presence of the parents or of a guardian.

Cookies

A cookie is an alphanumeric identifier that Football Village transfers to the User's computer through the Internet browser and that comes memorized on the hard drive of its computer. The cookie file is used to recognize the User's computer when it visits the Website and to collect information from it. In Football Village

the cookies are used to identify the Users at the moment of their visit, to record relevant information about the sections visited on our website and the eventual preferences and habits of the User. This allows to trace us a profile of our Users, useful to the purpose to improve the Service and to reach a better quality of the product. The utilization of the cookie allows us then of to offer, to the Users that will want to make use of it, a personalized version of the web Service of Football Village

We remember however that the cookie does not transmit any personal data or information of the User.

Transfer or communication of the data

E-Calcio S.r.l. will not sell and will not share the personal data of the Users of Football Village with third parts, made exception for the cases and the goals already listed in this privacy policy.

E-Calcio S.r.l. will reveal information and personal data to other businesses of the same group, eventual business partner, as well as suppliers of services that process the information for our account.

E-Calcio S.r.l. will be allowed also to reveal the personal data of the Users to eventual businesses of services specialized in property solvency and credit in case this should become necessary.

In case of sale of the business and of its properties, the personal data of the Users may be revealed to the buyer.

Links to third parts

The Football Village website could contain announcements and connections to websites and services of third parts. Such websites and services could ask for the personal data, this shall be treated accordingly to the privacy policy and to the terms and conditions of use specific of those sites and services. It is of fundamental importance that the Users will always read the privacy policy and the terms and the conditions of use of the websites visited because they can defer greatly from those of this website.
